


### MONTANA PROJECTS ON THE TRE:


**Culbertson-East:** complete reconstruction currently underway between Culbertson and Bainville.

**US 2 Culbertson**: Major rehabilitation through the town of Culbertson-will include a storm drain system curb/gutter and sidewalk. (2022-2023)

**Bainville-East Ph II**: Adding 2 additional lanes (separated) between Bainville and the ND State Line. (No current funding solution)



### Transportation Needs vs Funding Current 10-year Estimate 2018-2027




### Highways (HSSRA)& Bridge and Road Safety Accountability (BaRSAA)

## Constitutionally Restricted for:

- Payment of obligations incurred for construction, reconstruction, repair, operation and maintenance of public highways, streets, roads and bridges.
- Payment of county, city and town obligations on streets, roads and bridges.
- Enforcement of highway safety, driver education, tourist promotion and administrative collection costs.

### • Primary Revenue Sources


- Gasoline and Diesel Tax
  - \$0.31 per gallon of Gasoline
  - \$0.2875 per gallon of Diesel
  - Increase passed during the 2017 session (HB473)
- GVW Permits and Fees
- Cost Recoveries from Federal, Private and Local Partners
